

PRIVACY STATEMENT

We value your right to privacy and strive to protect your personal data that we collect. We want to make sure that you understand what kind of information we will be collecting from you and how it will be used. In this Privacy Statement we describe which personal data we collect, how and for which purposes we process your personal data, to whom personal data is disclosed by us and how you can exercise your privacy rights. Therefore, we encourage you to read this Privacy Statement carefully. We may need to amend this Privacy Statement from time to time. The most recent version of this Privacy Statement is available on our website. Finally, we would like to point out that we are continually developing and improving our website. If this brings about any changes in the way we process personal data, this will be reflected in this Privacy Statement. We therefore recommend that you regularly take notice of the Privacy Statement for any modifications.

1. Who we are

This Privacy Statement applies to the IMC Prosperity Global Trading Challenge. IMC is a global group of companies with entities and operations in, amongst others, the Netherlands, the United States, Australia, India, and the United Kingdom.

For the purposes of data protection law, the controller responsible for the processing of your personal data depends on your location and the IMC entity that determines the purposes and means of the processing related to the Global Trading Challenge:

- If you are located in the European Economic Area, the United Kingdom or Switzerland, the controller of your personal data is the IMC entity that determines the purposes and means of the processing in your region. This may be:
 - IMC Netherlands Services B.V. (Netherlands),
 - IMC London Ltd or IMC London Services Ltd (United Kingdom), or
 - the IMC filial in Denmark,
depending on which entity organises or administers your participation in the Challenge.

- If you are located in the United States, the controller of your personal data is the relevant US entity within the IMC Group that determines the purposes and means of the processing for your participation in the Challenge (collectively, "IMC US"), including IMC Americas, Inc., IMC Chicago, LLC, IMC Securities LLC, IMC Execution Services LLC, and IMC Markets.
- If you are located in Australia, the controller of your personal data is: IMC Pacific Pty Ltd, which determines the purposes and means of processing for individuals in Australia.
- If you are located in Hong Kong SAR, the controller of your personal data is: IMC HK Services Ltd, which determines the purposes and means of processing for individuals in Hong Kong SAR.
- If you are located in India, the controller of your personal data is: IMC India Securities Private Limited, to the extent that this entity determines the purposes and means of processing in connection with your participation in the Challenge.

Notice for Individuals located in India

If you are located in India, this Privacy Statement constitutes notice under the applicable laws in India. We process your personal data only for the purposes mentioned in this Privacy Statement, for which you have given consent. Because IMC operates as a global group, your personal data may be transferred to and processed in countries outside India, including jurisdictions where IMC group entities or service providers are located, for which you have given consent. You may withdraw your consent at any time by contacting us at IndiaHRteam@imc.com. Withdrawal of consent will not affect the lawfulness of processing carried out before such withdrawal.

Other IMC group companies may act as processors or joint controllers where they support or jointly participate in organising or administering the Challenge. Where required, IMC has implemented appropriate intra-group arrangements.

You can contact the relevant controller using the contact details provided at the end of this Privacy Statement.

2. To Whom This Privacy Statement Applies

This Privacy Statement applies to:

- Participants: individuals who register for and/or take part in the Prosperity Challenge.

- CRM contacts: individuals whose contact details are stored in our customer relationship management system (e.g. ActiveCampaign) for recruitment and marketing purposes, including Participants and Lead Gen who have opted in.
- Website visitors: individuals who visit the Prosperity microsite and interact with its forms and content.
- Participation in the Prosperity Challenge is subject to the eligibility requirements set forth in our Terms and Conditions, including that participants must be at least 18 years of age at the time of registration.

3. How and Why We Process Your Personal Data

(Categories of data, purposes, legal basis)

We only process personal data that is necessary for the purposes described below.

The specific data used depends on whether you are a Participant, Lead Gen contact, CRM contact, or website visitor.

4. With Whom We Share Your Personal Data

We may share your personal data with:

- Other IMC group companies that support Prosperity, recruitment and marketing activities, in their capacity as controllers, joint controllers or processors, as described in Section 1.
- Service providers that process personal data on our behalf, including:
 - Hypersolid, which designs, hosts and operates the Prosperity microsite and Challenge platform and maintains the Prosperity database;
 - Greenhouse Software, Inc., which provides our recruitment platform and stores participant data transferred from Prosperity;
 - ActiveCampaign or similar CRM/marketing platforms, which we use to send marketing and information emails;
 - IT, hosting, email and other technical providers that support Prosperity.
- Professional advisers (such as legal or tax advisers) where reasonably necessary.
- Public authorities, regulators or courts, where we are legally required to do so.

When we work with service providers, we put in place appropriate data processing agreements to ensure your personal data is protected and only used according to our instructions.

5. International Data Transfers

Because IMC is a global group, your personal data may be transferred to and processed in countries outside of your own, including countries outside the European Economic Area and the United Kingdom (for example, the United States, Australia and India).

Where required by law, we take appropriate safeguards to protect such transfers, including:

- entering into Standard Contractual Clauses or equivalent contractual safeguards; and
- implementing additional technical and organisational measures where appropriate.

You can request more information about the safeguards used for international transfers by contacting us using the details above.

6. How Long We Keep Your Personal Data

We keep your personal data only for as long as necessary for the purposes described in this Privacy Statement, and in line with our internal retention policies and applicable laws. In particular:

- Prosperity participation data (including scores and game activity) is typically retained for up to 12 months after the end of the relevant edition of Prosperity, for reporting, audit, dispute handling and to improve future editions.
- Participant data in Greenhouse used for recruitment purposes is generally retained for up to 2 years after your last relevant interaction with IMC (for example, after the last recruitment activity in which you were involved), unless a longer or shorter period is required by local law.
- CRM contacts (ActiveCampaign) are retained up to 2 years, and we apply periodic data hygiene reviews to ensure we do not retain personal data longer than necessary for active marketing purposes. You can unsubscribe from CRM communications at any time by using the unsubscribe link at the bottom of the email.
- Technical logs and security data are retained for shorter periods where possible, typically 12 months, unless needed longer for security investigations or legal purposes.

We may retain certain information for longer where necessary to comply with legal obligations, resolve disputes, or enforce our agreements.

7. Whether You Have to Provide Personal Data

You are free to decide whether to participate in Prosperity or to sign up for marketing communications.

However:

- Some personal data (such as name, email address and country of residence) is necessary for us to register you, operate the Challenge and communicate with you. Without this information, you will not be able to participate.
- Providing your details for CRM marketing purposes is voluntary, and you can withdraw your consent or opt out at any time.

8. Your Rights

Depending on your location and subject to legal conditions and exemptions, you may have the following rights in relation to your personal data:

- Right of access – to obtain confirmation and a copy of your personal data we hold.
- Right to rectification – to have inaccurate or incomplete data corrected.
- Right to erasure – to request deletion of your personal data in certain circumstances.
- Right to restriction of processing – to request that we limit the processing of your personal data in certain cases.
- Right to data portability – to receive certain personal data in a structured, commonly used and machine-readable format and to transmit it to another controller.
- Right to object – to object, on grounds relating to your particular situation, to processing based on our legitimate interests, including profiling; and to object at any time to processing for direct marketing purposes.
- Right to withdraw consent – where processing is based on your consent, you may withdraw that consent at any time. This does not affect the lawfulness of processing based on consent before its withdrawal.
- Right not to be subject to a decision based solely on automated processing, including profiling, which produces legal effects concerning you or similarly significantly affects you, unless certain conditions are met.

(Prosperity scoring and ranking are used to run the Challenge and award prizes but are not intended to produce other legal or similarly significant effects outside the context of the Challenge.)

- Right to Nominate (India) - If you are located in India, you have the right to nominate another individual who may exercise your rights under the applicable law in India in the event of your death or incapacity.

To exercise your rights, please contact us using the details provided in Section 1. We may need to verify your identity before responding to your request.

You also have the right to lodge a complaint with your local data protection authority, in particular in the EEA or UK country where you live or work, or where you consider that a breach of data protection law has occurred.

9. U.S. State Privacy Rights

This Section applies to residents of U.S. states with applicable privacy laws, including California, Colorado, Connecticut, Virginia, Utah, Texas, Oregon, Delaware and New Jersey. Where there is a conflict between this Section and other parts of this Privacy Statement, this Section controls for residents of those states.

In the preceding 12 months, we have collected the following categories of personal information (as defined under California law):

- Identifiers – such as name, email address, IP address, username, participant ID.
- Internet or Other Electronic Network Activity Information – such as browsing activity, log data, device information, cookie identifiers and engagement metrics.
- Geolocation Data (Approximate) – such as country or region derived from IP address.
- Education Information – such as university name, degree, discipline, start and end year.
- Commercial Information – such as participation records, gameplay activity, rankings and prize eligibility.
- Sensitive Personal Information – such as bank account details and tax identification information required for prize payments (collected only from prize winners where necessary) and optional demographic information such as gender (if you choose to provide it). We do not use or disclose Sensitive Personal Information for purposes other than those specified in CPRA Section 7027(m). California residents may exercise their

right to limit use of Sensitive Personal Information using the methods described below, though in most cases our use already falls within permitted purposes.

We collect this information directly from you, automatically from your device, and from service providers acting on our behalf. We collect and use personal information for the purposes described in Section 3 of this Privacy Statement.

We may share certain identifiers and internet activity information (such as cookie identifiers, IP address and device information) with advertising and analytics partners for cross-context behavioral advertising and campaign measurement purposes. Under California law, this may be considered "sharing" personal information. You have the right to opt out of this sharing by clicking the "Do Not Sell or Share My Personal Information" link in the footer of the Prosperity website or by contacting us at PrivacyUS@imc.com. We do not sell personal information for monetary consideration, meaning we do not exchange your personal information for money.

To exercise your right to opt out of sharing for targeted advertising, you may:

- Click the "Do Not Sell or Share My Personal Information" link located in the footer.
- Email us at PrivacyUS@imc.com with "Opt-Out Request" in the subject line; or
- Enable Global Privacy Control (GPC) in your browser settings.

Once you opt out, we will stop sharing your personal information with advertising partners for targeted advertising purposes. Please note that opting out of sharing is separate from managing your cookie preferences, though both can affect your experience with targeted advertising.

Residents of applicable U.S. states may have the following rights:

- Right to Know / Access – to request disclosure of the categories and specific pieces of personal information we have collected.
- Right to Delete – to request deletion of personal information, subject to legal exceptions.
- Right to Correct – to request correction of inaccurate personal information.
- Right to Data Portability – to receive a copy of personal information in a portable format.
- Right to Opt Out of Sale or Sharing – to opt out of the sale or sharing of personal information.

- Right to Opt Out of Targeted Advertising – to opt out of processing for targeted advertising.
- Right to Limit Use of Sensitive Personal Information (California residents only) – to limit use of sensitive personal information to what is necessary to perform services or provide requested goods.
- Right to Non-Discrimination – we will not discriminate against you for exercising your privacy rights.
- Right to Appeal (where applicable) – if we deny your request, you may appeal our decision by contacting us as described below.

We will verify your identity before processing your request. Verification may require confirming certain information we already hold.

California residents may designate an authorized agent to submit a request on their behalf.

We will respond within the timeframe required by applicable law (generally 45 days, with an extension where permitted).

If your request is denied, you may appeal our decision by contacting us at PrivacyUS@imc.com.

We retain each category of personal information only for as long as reasonably necessary to fulfill the purposes described in this Privacy Statement, including to comply with legal, tax, accounting and regulatory obligations.

10. Automated Decision-Making and Profiling

Prosperity involves automated scoring and ranking of participants based on their performance in the Challenge. These automated processes are necessary to operate the Challenge, determine progression through rounds and identify winners.

Outside of the Challenge context, IMC may use Prosperity performance data, together with other information in our recruitment systems, to help identify potentially suitable candidates. This may involve a degree of profiling (for

example, grouping participants based on performance, study background or engagement level). However, we do not make hiring decisions solely on the basis of automated processing; meaningful human involvement is always present in recruitment decisions.

If you have questions or concerns about any automated processing, you can contact us and, where applicable, request human review.

11. Changes to This Privacy Statement

We may update this Privacy Statement from time to time, for example to reflect changes in Prosperity, our processing activities or applicable law. The updated version will be posted on the Prosperity microsite with a revised "last updated" date. Where changes are material, we will take appropriate steps to inform you.
